Application System Guidance

After you register in our system, you will be able to start an application form for your opportunity of choice. Don't forget to submit your application before the deadline.

Step-by-Step Instructions

- 1. Register in the application system
- 1.1 Begin your registration
 - 1. Go to https://apply.eithealth.eu
 - 2. Click on the "Register" button on the bottom left corner



- 3. In the registration page, please choose the option that best represents you:
 - Individual
 - Representative of a start-up team
 - Representative of an organisation (excluding start-ups)

Please select the option below that best describes you: Individual Please select this option if you are looking for opportunities as an individual or expert, and you are not applying as part of a start-up or an organisation. Please note that you will not be able to apply to the Flagships Calls if you select this option. Representative of a start-up venture/team Please have the information about your company/team at hand as you will need it to register in the system. If you are part of a start-up venture, you will be able to apply to EIT Health acceleration programmes and the Flagships Calls. Representative of an organisation (excludes start-ups) Please select this option if you wish to apply as a representative of an organisation, such as industry, academia, research, hospitals, NGOs, cluster organisations, cities or municipalities. This option includes EIT Health Partners or Members (e.g., Core Partners, Associate Partners, and affiliated entities of both) and organisations that are new to the EIT Health Community. If this option best describes you, you will be able to apply to our Flagships Calls. Please note that if you select this option, it may take up to 48 hours for your registration to be approved.





1.2 Find or enter your start-up team or organisation name in our database

- **1.** If you select "Representative of a start-up team" or "Representative of an organisation" in the registration options, you will need to find your start-up or organisation in our database.
 - a. First, enter the name of your start-up team or organisation. If your entity's information is already stored in the broader EIT Health database, the application system will suggest a match as you type in the name of your start-up or organisation.
 - b. Click on the correctly suggested name. The application system will populate the information that EIT Health has available for your start-up or organisation. Please check that the information is correct.



2. If the dababase does not suggest a name match, you will need to add it to the application system using the provided link in the help text, also shown here:

Start-up/Team Information
 You have selected to register on behalf of a start-up or team (either registered or not) Enter the name of your start-up/team. As you start typing a name, our database will suggest a match then click on the name. If you can't find your start-up/team, click here to add it. If you are looking for another organisation (such as partners, industry, academia, university, clusters, etc.), please go back to the main page and select the corresponding registration option.

1.3 Confirm your registration

- 1. To confirm your registration, go to the email account you used to register in the application system.
- 2. Look for an email message from 'noreply@smartsimple.com'.
- 3. Reset your password by clicking on the link provided in the email message. If you registered as a "Representative of an organisation (excluding start-ups)", EIT Health will need to approve your account before you receive this email message. Please allow two-to-three days to receive approval.
